NOTICE IS HEREBY GIVEN that the Coast Community College District acting by and through its Governing Board will receive sealed bids for the award of a contract for the following named project. Bids will be received up until, but not later than, the bid deadline listed below.

Project Description: This bid is for the construction of a 950 square foot building complex including a mens' restroom, womens' restroom, and combined ticket booth/concession area. This complex will be constructed on the existing slab apron located behind the Orange Coast College Baseball Field backstop and must be constructed in accordance with approved Division of State Architect plans and specifications.

Each bidder shall be a licensed contractor pursuant to the Business and Professions Code §7028.15 and California Public Contract Code §3300. The District requires that the bidder possess at the time of bid and maintain throughout the duration of the contract a **B license** classification(s):

Project Timeline: Time is of the essence. This project must be completed within the contract duration specified in the project Special Conditions. Failure to achieve substantial completion within the contract time will result in the assessment of Liquidated Damages.

**Pre-Qualification is MANDATORY.** The prequalification package must be received by the Office of Purchasing, at the above identified address, no later than Tuesday, March 22, 2011 at 10:00 a.m. Only prospective bidders deemed to be "pre-qualified" by the District will be eligible to submit bids for this project. A **MANDATORY pre-bid job-walk** will be held at 10:00 a.m. Wednesday March 30, 2011 at Orange Coast College, 2701 Fairview Road, Costa Mesa, CA 92626. The baseball field is located on Monitor Way off of Fairview Road.

Bid and contract documents will be available at the job-walk and will thereafter be available at the location stated above. Bidders may pick up ONE set of documents at no cost. Each additional set will be at a non-refundable charge of fifty dollars (\$50).

All bids shall be submitted on the forms furnished by the District, must be received in the Office of Purchasing at the address identified above, and will be opened and publicly read aloud immediately upon the close of bids. Incomplete, inaccurate, or untrue responses or information provided therein by a bidder shall be grounds for the District to reject such submissions for non-responsiveness.
