Project Description: This is a multiple-prime delivery project for the construction of a multi-function 66,000 square foot educational facility and associated site development to be located at 1515 Monrovia Avenue in Newport Beach. The scope of work covered under this bid is specifically limited to the below listed trades as defined in the project plans and specifications. All other trades have been previously bid and awarded. Each bidder shall be a licensed contractor pursuant to the Business and Professions Code §7028.15 and California Public Contract Code §3300. The District requires that the bidder possess at the time of bid and maintain throughout the duration of the contract the following classification(s):
