## 22.01 DIS – Funded Programs

**Orange Coast College (OCC)** received a renewal for the California Department of Education, Child Development Division grant titled, “**Harry & Grace Steele Children’s Center General Child Care & Development Program Grant (CCTR-6157)**.” The Children’s Center had received funds to subsidize childcare for low-income student-parents since 1978. OCC provides comprehensive child development services that include: quality childcare for student-parents enrolled at OCC, a food and nutrition program, parent enrichment and resource/referral services. This funding provided child care services for infants and toddlers of low-income students enrolled in a minimum of 6 units while attending OCC, Golden West College or Coastline Community College.

**Fiscal Impact:** OCC will receive \$212,002 from July 1, 2016 to June 30, 2017. No matching funds required.

**Orange Coast College (OCC)** received a renewal for the California Department of Education, Child Development Division grant titled, “**Harry & Grace Steele Children’s Center California State Preschool Program Grant (CSPP-6316)**.” This funding provided child care services for preschool children ages 3-5 years of low-income students enrolled in a minimum of 6 units while attending OCC, Golden West College or Coastline Community College.

**Fiscal Impact:** OCC will receive \$140,830 from July 1, 2016 to June 30, 2017. No matching funds required.

Physical Security System Upgrade Project Bid No. 2064**

Mr. Rob Schneiderman addressed the Board.

The access control installation would include wired and wireless card readers on existing classroom doors. This project would provide 82 additional

security cameras on campus and deploy a new video management and storage platform. Furthermore, GWC sought to install 27 new emergency phones on campus which would have mass notification/public address capability.

Notices for pre-qualification were published on February 4, 2016 and February 11, 2016. 21 packets were received and seven prospective bidders were pre-qualified. Two bids were received and opened on June 23, 2016. This work would commence immediately (Summer 2016) with an expected construction duration of one year.

accessibility and reliability in the instructional areas that rely on wireless technologies as a pedagogy as well as expand the capacity and increase performance by three fold. A reduction in the duplication and complexity of the current infrastructure would improve the network manageability, scalability, reliability, and security risk which would significantly simplify the experience of the students, faculty and staff.

A total of 10 vendors were solicited for the Enterprise Wireless and Enterprise WAN project. The roll out of these projects would allow the Coast Community College District to implement current and future wireless initiatives that were directly related to the enhancement of student learning and skill development. In addition, the required infrastructure equipment to implement the Enterprise Wireless and WAN projects would modernize and expand the existing equipment used for direct support of instruction. The wireless procurement was being broken into three phases to accommodate the deliverable date of fall semester 2016.

Phase 1 procurement of \$600,000 of 2015-16 Mandate Reimbursement Funds was approved by the Board of Trustee on May 18, 2016. The distribution of funds was delineated as:

- Teraband/ACS apportion of \$304,315 is allocated to implement the wireless cabling for Orange Coast College.
- ePlus apportion of \$295,685 is allocated for the Cisco Wireless hardware for Orange Coast College.

Phase 2 procurement of \$588,000 of 2015-16 Mandate Reimbursement Funds was approved by the Board of Trustee on June 15, 2016. The distribution of funds was delineated as:

- Teraband/ACS apportion of \$13,153 will be allocated to complete Orange Coast College wireless cabling and to start the implementation of Golden West College wireless cabling.
- ePlus apportion of \$574,847.28 will be allocated to complete the Orange Coast College wireless project and to start the implementation of Golden West College wireless hardware.

Phase 3 procurement of \$2,898,255.76 would include the approval of the remainder of the associated costs at the July 13, 2016 Board Meeting.

- Teraband/ACS apportion \$462,875 of will be allocated to complete the wireless cabling project at GWC, CCC and the District
- ePlus apportion \$1,119,899.28 of will be allocated to the procurement of the remaining Cisco wireless hardware for GWC, CCC and the District
- Altware apportion 774,028.52 will be allocated for the procurement of the District-Wide Firewall and the Wireless management appliance
- Trace3 apportion (\$169,974.88) of will be allocated to support the F5 Load Balancer

The District Purchasing Manager reviewed the following pricing agreements and determined the pricing to be fair and reasonable:
