
Please complete this application and submit it with all required materials. **All application materials must be received by the Board Office no later than Friday, February 6, 2026, at 5:00 p.m.**

Eligibility Requirements (Trustee Area 3)

Applicants must:

- Reside in Trustee Area 3 of the Coast Community College District, which includes Huntington Beach and portions of Westminster
- Be at least 18 years of age
- Be a registered voter
- Not be disqualified from holding civil office under the Constitution or laws of the State of California
- Not be employed by the Coast Community College District while serving on the Board

Before completing and submitting this application, applicants must verify residency by contacting the Orange County Registrar of Voters at 714-567-7586.
